# **CAMILLA CROSO**Multistakeholderism in global education governance

Camilla Croso is division director of Initiatives at the Open Society Foundations, having previously been director of its Education Program. Croso joins Open Society from the Latin American Campaign for the Right to Education, where she was general coordinator. Based in Brazil, Croso led the regional network, working for effective implementation of the right to education in 18 Latin American countries. She was president of the Global Campaign for Education, sat on the board of directors of the Global Partnership for Education, and has integrated both Global and Regional Sustainable Development Goal 4 and Education 2030 Steering Committees.



# FRANK ADAMSON Global Education Reform

Assistant Professor of Education Leadership and Policy Studies at California State University, Sacramento (USA). Senior Policy and Research Analyst, SCOPE Center, Stanford University (Jan. 2015 – August 2018). Dr. Adamson studies how different political and economic approaches to education relate to student experiences and opportunity in schools and communities. His latest research examines international and U.S. saturation levels of education privatization and implications for education equity. Adamson's volume Global Education Reform compares the approaches of privatization and public investment to education policy in six countries. His latest volume, Realizing the Abidjan Principles on the Right to Education: Human Rights, Public Education, and the Role of Private Actors in Education, was published in 2021.



## **GONZALO BERRON**

Project director at the Friedrich Ebert Foundation - Brazil. He is an associate fellow of the Transnational Institute (TNI) and a member of the TNI Corporate Power Team. Currently develops research on BRICS, Agenda 2030 and the Sustainable Development Goals (SDGs). Coordinates the UnB 2030 Strategic Program: Sustainability and Inclusive Development. Leader of the Research Group Center for Studies on International Relations in Contemporary Brazil registered with CNPQ.

## DAVID ARCHER

Transforming Education Summit: next steps

David Archer is the Head of Programmes and Influencing with ActionAid's Global Secretariat, leading work on system change for climate justice, economic justice, public services and women's rights. He was the Stakeholder Convenor for the Transforming Education Summit Action Track on Financing in September 2022. David qualified as a trained teacher and researched adult learning programmes inspired by Paulo Freire across Latin America (Literacy and Power), developing the Reflect approach in the 1990s. He is a co-founder of the Global Campaign for Education and Chair of the Right to Education Initiative. From 2018-2020 he served as chair of the Strategy and Impact Committee of the Global Partnership for Education. Recent publications include The Public Versus Austerity: Why public sector wage bill constraints must end and The Vicious Cycle: connections between the debt crisis and the climate crisis.



## MARCELO DI STEFANO Threats to public services

Adjunct Professor of Labor Law and Social Security at the Faculty of Economic Sciences at the University of Buenos Aires and Associate Professor of Principles of Human Rights and Constitutional Law of the Common Basic Cycle at the University of Buenos Aires. Professor at the Faculty of Education of the University of São Paulo and member of the Steering Committee of the Brazilian Campaign for the Right to Education. He was general coordinator of the Campaign from 2006 to 2020. He was awarded the Darcy Ribeiro Prize in 2015 by the Brazilian Chamber of Deputies on behalf of the National Congress. He has worked to improve the legal texts and approval of educational policies such as the National Education Plan (2014-2024) and the constitutionalization of the new and permanent Fund for the Maintenance and Development of Basic Education and Valorization of Education Professionals (Fundeb) with the Student Cost of Quality (CAQ) and the National System for the Evaluation of Basic Education (Sinaeb).



## **DIEGO PARRA** Chile

Researcher at the ALERTA Center and the Chilean Observatory of Educational Policies (OPECH) at the University of Chile. He holds a doctorate in psychology from the same university and is part of its psychology and education program, where he researches the history of psychology linked to the development of the Chilean education system. He is also a member of the country's Forum for the Right to Public Education. He has already contributed to the Latin American educational debate with academic articles on corporate power in Chile's educational and constitutional debate, and the commodification of education in his country.



## **ISABEL DA SILVA** Mozambique
