John Cavanagh has been the Director of the [Institute of Policy Studies](#) in DC since 1998 and is a founding TNI fellow. Formerly an economist with UNCTAD and the WHO, he is the TNI Board of Trustee Chair and sits on the executive committees of the US-based Alliance for Responsible Trade and the Citizens' Trade Campaign. Cavanagh helped establish the International Forum on Globalisation in 1995, and has been active in the anti-NAFTA networks. He works closely with the Progressive Caucus of the US Congress and the international department of the US trade union federation, the AFL-CIO, on corporate accountability and international labour rights. He is the co-author of 10 books and numerous articles on globalisation. Cavanagh has a BA from Dartmouth College and a MA from Princeton.
